In addition to increasing harmony in the neighborhood, knowing your neighbors is the optimum way of increasing neighborhood security. The board plans to cater the block parties, but we will need sponsors to host each party. We will be looking for one or two sponsors per street to serve as hosts and to help coordinate activities. Food and drink tickets will be provided to each homeowner. Since many of you are not totally

Should the HOA Maintain YourPersonal Property?

The editor of the Polaris Beacon finally received a suggestion from a member of the community. A pleasant surprise. Mrs. Devon Vaughn (a former board member) expressed concern regarding the cosmetic appearance of the mailboxes throughout our community. They are all old, heat damaged, and look terrible. I agree!

She suggested that the HOA fund the refurbishing of all 149(?) mailboxes in the neighborhood. That would require painting of the boxes and stands as well as the red, "send mail" flags.

As editor, I responded that this did not seem appropriate since the board does not maintain the personal property of any homeowner (e.g. painting of garage doors, landscaping of front yards, applying weed killer, etc.). She responded by email that previous boards (specifically, the recently recalled board) have funded special trash pickups, trash dumpsters and garage sales. My reply was that those events ended up benefiting a minority of homeowners at the expense of the entire community. Her response was that this board scares the bejeezus out of her. Calm down, Devon. We are actually on your side, and we want to do things right.

To be politically correct, the issue will be discussed at the July Board meeting.

In the meantime, I have taken 15 minutes of my time and repainted both my mailbox and that of my neighbor. The boxes do look better, and I would certainly be happy to see others do the same. The job is simple, inexpensive and it generates good feelings. Cost of a spray can of gloss-black enamel, which will easily paint up to six or more mailboxes, is around \$7.

For the DIY Crowd

The homes in this neighborhood are between nine and 11 years in age. They were mostly supplied with the same kitchen appliances, so I am assuming that each home has experienced deterioration in the performance of the installed GE Nautilus Dishwasher. If not and you have one, it will happen soon. Can 15 minutes save you 3000%. Probably!


Here is a report from a recent personal experience. Our dishwasher began to fail to clean the dishes. It was not due to the way dishes were stacked, or to detergent or to hard water, etc. The first suspicion was that the motor or the impeller was faulty. Both suspicions were wrong. It looked like we were facing an expensive dishwasher replacement. To make a long story short, the repair took 15 minutes to replace a \$12 part.

The dishwasher has a spring-loaded plastic valve at the bottom rear of the inside of the washing chamber (see Fig. below) that acts as both a siphon break and a pressure diverter.

The plastic valve erodes and fails to deliver pressure to the wash tower. Therefore – poor washing. The deteriorated valve, which can be easily removed and replaced by hand, is shown in the Figure below

There was a moment of hope in June when Jeff Cesare (Joe Cesare's son) responded to many voice mail messages from Mr. Dave Blankenbaker requesting a meeting. Jeff agreed to set up a telecom conference among Mr. Blankenbaker, Dr. Borom, his father and himself on the week of June 13th. Wildlife (the 8-legged kind) in Star Valley

Solpugids, known also as windscorpions or sunspiders are non-poisonous members of the arachnid family. They just look fierce. They could readily serve as a model for a movie like Alien. Solpugids are beneficial predators since their diet consists of insects - like crickets, roaches, termites, etc.- and some small vertebrates like lizards. If you find a windscorpion in your home, it got there looking for food. Catch it and release it outside to work for you there then patch all holes around your doors and windows to avoid further entry. Their most striking characteristic is the powerful set of double-hinged and independently mobile jaws, which they use to tear their prey apart.

They **ARE** scary, but relatively harmless and remember - they are beneficial.



Don't try this at home. This specimen drowned in the pool and is dead. The hand is just for size reference. Even dead it is still pretty frightening!!
