Approval of the 2011 Annual Meeting Minutes passed with 43 ballots in favor of approval and 2 opposed. **MOTION** by Mr. Blankenbaker to amend the 2011 Annual Meeting Minutes to show 50 votes not 48 votes:

#### **ELECTION:**

- Presentation of slate of candidates- Dan Harper, Gale Nelson (Ozzie), Nadine Williamson
- Ballot count and election results Dan Harper received 35 votes, Gale Nelson (Ozzie) received 33 votes, Nadine Williamson received 22 votes, Jill Chamberlain received 1 write in vote, and Richard Curtin received 1 write in vote. Dan Harper and Gale Nelson (Ozzie) are elected to the Board of Directors.
- Ozzie Nelson and Dan Harper were elected to two year terms each. The expiring directors were Dan Brees and Dan Harper (appointed to fill the seat vacated by Brian Scott).

### **HOMEOWNER OPEN FORUM (QUESTIONS AND ANSWERS)**

- Jimmy Williamson informed the community that Mr. McHenry passed away, he was a prior Board member.
- Jimmy Williamson asked about the process for refunding homeowners; information will be in the newsletter. Discussion ensued.
- Emily Smith asked about refurbishing/replacing mailboxes and paint colors for homes.
- Jill Chamberlain stated that the total number of votes cast was incorrect on the 2011 Annual Meeting Minutes; this will be corrected by an amendment.
- Pat Linn asked if there could be an actual expense column/year to date expense column added to future budgets. Input from Jimmy Williamson and the Board during discussion.
- Jimmy Williamson asked if there could be refreshments at the meetings.
- A homeowner informed the members of gas pumps, Fry's, and a golf course that will be built at Mark and Valencia.
- Discussed changing meeting times to 7:00 PM or 7:30 PM.
