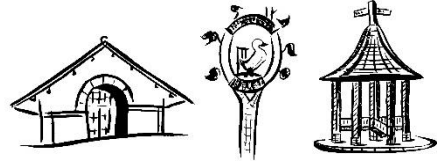

Wonersh Parish Council Members' Code of Conduct

LOCALISM ACT 2011 Section 29

The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012
