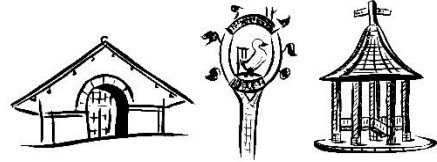

Wonersh Parish Council Members' Code of Conduct

LOCALISM ACT 2011 Section 29
