Such as lawn ornaments, landscaping, play equipment, fountains, mailboxes, etc.

Submit proposal with proposed modifications to scale on lot survey.

Painting or Re-Painting (No Review Charge) (approved paint colors available from ARC)

- a Main house area attach color swatch and paint description to this application. Paint a 2'x2' section on side of house one (1) week prior to ARC meeting.
- b Trim areas attach color swatch and paint description to this application. Paint a 2' section of trim on side of house, adjacent to the 2'x2' section under (b) above, one (1) week prior to ARC meeting.
- c Driveway attach color swatch and samples (if applicable).

Review and approval of plans and specifications submitted hereunder is made on the basis of aesthetic considerations only and the ARC shall not bear any responsibility or liability for ensuring the structural integrity or soundness of approved construction or modifications, nor for ensuring compliance with building codes and other governmental requirements.

The undersigned property owner hereby acknowledges and agrees that the undersigned shall be solely responsible for determining whether the improvements, alterations, or additions described herein comply with all applicable laws, rules, regulations, codes and ordinances; including, without limitation, zoning ordinances, subdivision regulations, and building codes. Construction or improvements for which plan approval is granted here under must (a) commence within six (6) months from the approval date and (b) be completed and a certificate of occupancy (when applicable) issued within twelve (12) months after construction commences. If construction has not commenced within said six (6) month period, this approval shall be null and void and a new application must be submitted.
