It's a great opportunity to check out some quality, yet affordable options for junior golf equipment. All campers are welcome. You never know if last year's golf clubs still fit your growing junior golfer!

Cost: \$180 per child

(Pay only \$160 for each additional sibling or additional camp a child enrolls in.)

No applications will be accepted without payment. Registration fees are nonrefundable if we are unable to fill your child's place in camp.

<u>Lunch</u>: Plan to eat in the grill room following camp! Each afternoon will feature a lunch special for all campers.
