

## Ways to Support Us. . .

The 1990 Legacy Society was created to recognize supporters who make gift plans to benefit our housing ministry throughout and beyond their lifetimes. Legacy gifts made to SCHH help ensure that decent affordable shelter will be available for future generations.

Please consider making SCHH a part of your estate plan. Your gifts may include, but are not limited to:

### BEQUESTS

Gifts through a will or trust that could include cash, real estate, stocks, and bonds.

### CHARITABLE GIFT ANNUITIES

Contracts that provide you or your beneficiaries a fixed annual income in return for your tax-deductible donation of cash, investments, or other assets.

### RETIREMENT ACCOUNTS

Name SCHH as a beneficiary of your retirement plan assets, possibly reducing your heirs' tax burden.

### LIFE INSURANCE POLICIES

Name SCHH as a beneficiary and/or owner of life insurance contracts you no longer need.

### CHARITABLE TRUSTS

Through special arrangement establish a trust and name SCHH the beneficiary, often reducing your taxable estate and gaining tax benefits for yourself or your heirs.

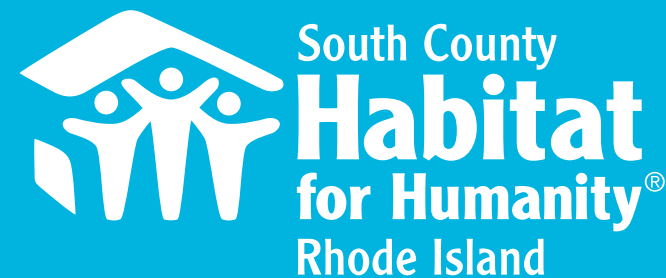
