



Bintelli LLC End User Warranty Policy

Bintelli LLC is pleased to offer the following product warranty for "On Road" Adly branded units. Warranty begins on the day of delivery to the end user. Bintelli LLC warrants all parts of the vehicle for a period of (2) years except those listed the "limitations of liability". Warranty repairs cover parts and labor costs. This warranty remains active provided that the following conditions are met:

- An authorized Adly dealership performs the initial vehicle setup and submits a completed pre-delivery checklist along with a completed warranty registration within fifteen (15) days of the sale of the unit.
- Vehicle MUST BE INSPECTED by an authorized Adly dealership within 500 miles or 90 days from the date of purchase, whichever comes first. Failure to do so will render the limited warranty null and void. The end user is required to maintain a dealer inspection record which will be requested for any warranty coverage.
- All warranty work and repairs during warranty period are completed by authorized Adly dealerships.
- All requests for warranty work are directed to Bintelli LLC *prior* to beginning the repair.
- End user follows the maintenance schedule provided in the owner's manual and has all maintenance documented by an authorized Adly dealership. Oil changes for 150cc 4 stroke units are to be completed at a minimum of every six (6) months or fifteen hundred (1,500) miles, whichever comes first.

The following limitations of liability exist:

The warranty is transferrable one time after the initial unit's sale. It does not include minor surface rips, tears, fading, scrapes, blemishes, or other cosmetic damages due to normal use or other damage, whether intentional or unintentional. The warranty will also not cover damage due to the use of improper chemicals or cleaners that have been applied to the unit. Any misdiagnosis of the problem leading to improper repair will not be covered under the warranty. Unapproved modifications to the unit will void the warranty. Reimbursement will never be granted for towing, loss of time, loss of use, inconvenience, or damages that are consequential or inconsequential. The warranty only covers manufacturer defects. Battery is covered for one year. Any damage due to misuse or neglect or failure to properly maintain the product will not be covered by the warranty. Failure to use the correct type of oil or running the scooter without oil will void the warranty. Standard wearable parts including belts, tires, filters, clutch/friction material, brake pads, spark plugs, fluids, bulbs, body panels, and other expendable parts are not covered by the warranty. The warranty will not apply for damaged units used for rental purposes. Transportation damage will not be covered under the warranty. Any transportation damage must be noted on the delivery slip when signing for the delivery or the carrier will not cover damage that occurred during transit. All maintenance expenses are the responsibility of the end user. No coverage will be provided due to tornado, earthquake, flood, fire, or any other "acts of God". Bintelli may alter this document with or without notice at any time.
