 - 2019 Dues: \$1800
- Scholastic: Any person between ages 12-18. If a parent/guardian is not a member they will have no privileges at the club.
 - 2019 Dues: \$100 (No monthly payment option available).
- Student/College: Any young adult who attends college or equivalent schooling, on a full-time basis, and is under the age of 25. All applicants must submit proof of full-time schooling status. If a parent/guardian is not a member they will not have privileges at the club.
 - 2019 Dues: \$250 (No monthly payment option available)
- The Special 2018 Members
 - 2019 Dues: \$400
- □ Tier 1 Young Member (Age 18-25): For those individuals between the ages of 18-25, who are not full-time students. When the Member reaches age 26, they are required to pay the Tier 2 rates.
 - 2019 Dues: \$500
- □ Tier 1 & 1 Unlimited Cart Pass Young Member (Age 18-25): For those individuals between the ages of 18-25, who are not fulltime students. When the Member reaches age 26, they are required to pay the Tier 2 rates.
 - 2019 Dues: \$1000
- □ Tier 2 Young Member (Age 26-32): For those individuals between the ages of 26-32. When the Member reaches age 33, they are required to pay the regular member rates.
 - 2019 Dues: \$700
- □ Tier 2 & 1 Unlimited Cart Pass Young Member (Age 26-32): For those individuals between the ages of 26-32. When the Member reaches age 33, they are required to pay the regular member rates.
 - 2019 Dues: \$1200

Gift cards will be accepted for payment on a cart pass. Gift cards will not be accepted for payment on Membership dues. To receive the \$100 Discount dues must be paid in full by December 1, 2018. Anyone paying dues after December 1, 2018 will not be eligible for the discount and the dues should be paid by March 31, 2019. If paid monthly, the dues for the 2019 golf season will be accessed \$25.00, the member must pay 50% by December 1, 2018. The balance must be paid in 4 payments January thru April and any dues unpaid after April 30, 2019 will be accessed an additional 5%. If you are more than two months behind in paying your dues, you are considered delinquent and you will lose your playing privilege until all charges are paid up to date including a 10% late fee per month. Members who paid monthly in the past three years and were presented to the Board as Delinquent Members **DO NOT** have the option of paying monthly this year.
