CONDITIONS AND TERMS

1. Cost: \$150-\$175 flat fee based on the attached pricing sheet. Fee includes one 10’ x 10’ space for the duration of the event. You must provide your own tent(s), table(s), and chair(s). Vendor space is limited. Contract must be received via email or postmarked by April 5, 2019.
2. Vendor agrees to operate only within the space rented/assigned to it. Sales elsewhere in the Park, including in the parking lot, are not permitted.
3. Contract applications will be processed on a first come first serve basis. Applications will not be accepted without full payment. DAA reserves the right to approve or reject vendors for any reason and to select vendors to ensure a broad representation of products.
4. **No refunds of payments for vendor space.** This event is outside. If the Davidsonville Park fields are closed on the day of the event for any reason, including inclement weather, the event will be canceled. There will be no rain date.

5. Check in/set-up is from 8:00 AM–10:00 AM only. Your booth must be staffed at all times during the event. Vendors are requested to remain set up for as much of the event as possible.

6. Violators of the conditions & terms of this agreement will be asked to cease operating their booth & will forfeit their fee payment. They may also not be allowed to participate in any future DAA events.

HOLD HARMLESS AGREEMENT

It is necessary for all vendors to sign the following Hold Harmless Agreement for insurance purposes. An application without this signature is not deemed complete and will not be considered (even if payment is included).

I/We agree to protect, indemnify and save and keep harmless Anne Arundel County and the Davidsonville Athletic Association and its officers, directors, partners, and agents against and from any incident or other occurrence on or about Davidsonville Park, causing injury to person or property whomsoever and whatsoever and will protect, indemnify and save and keep harmless the above mentioned parties from any and all claim, costs or expenses arising out of our use of the aforesaid premises.
