1. Board president Andy Cloyd called the meeting to order at 10:30 a.m. Susan Kessler offered a devotional and prayer.

2. Minutes

A motion was made (Susan Kessler), seconded (Bob Simons) and passed to approve the minutes of the November 17, 2018 meeting as distributed in advance with the removal of item #13.

- 3. <u>Financial Report</u> *Rev. Scott Miller*
 - Funds ran close this month. Less than \$500 in checking. Used GVEC grant money and donations to make up the difference.
 - Funds have come in so that to date we are at about \$19,000 cash.
 - EOG would like to extend the water-line easement for 5 more years. The rate will stay at \$7,301.25 per year. No new contract is necessary.
 - Budget came in \$4,989.90 short. (With a \$5,000 donation we were even.) A little over \$89,000 of our revenue is oil royalty money.

A motion was made (Nathan Higginbotham), seconded (Janene Suggs), and passed to approve the financial report as presented.

- 4. Camp Director's Report Rev. Scott Miller
 - The next few months are booked.
 - We are currently turning groups away because we are already booked.
 - There is a rate increase for water that will amount to about \$200 per year for the meter plus an increase in the rate for water.
 - The lift station pump repair will be much less than feared. Less than \$300.
 - We are about to move ahead on ordering replacement AC units with the grant money. We are still a little short on required matching funds.
 - We have received good reviews on the website.
 - The pick-up truck still needs \$750 in repair. The work has not been done yet.

- It looks like there will be people interested to be interns for this coming summer. We will man a booth at a UTSA job fair to advertise more for these positions.
- 5. Open house planning Plaque (Andy), signs (Scott), & food (Janene & Billy)
 - Open House: Billie will help with food. Janene Suggs will help. Event will be February 16 at 2:00 p.m.
 - We need 4 signs printed. We have \$3,000 donated for this project so far. Scott will order them soon at a cost of \$1,950 from Sign Works. The same company we have been using for signs. We will still need post and hardware.
- 6. Work day planning Saturday, February 23.
 - Will be replacing boards on amphitheater and dock.
 - Will clear out more brush at entrance.
- 7. Communications update December matching drive successful © what's next?
- 8. Lunch
- 9. Scholarship funds update, online donation planning
 - No funds have arrived. There is no account.
- 10. Video updates, Website, Online Camp Registration for Chi Rho/CYF
 - Should have video in two weeks.
 - Website is good
 - Registration starts soon.

 - Don't have enough funds to paint at this time.
- 12. Ropes course update (woodpeckers) Bob Simons
 - Woodpecker houses are still not installed. May happen on upcoming workday.
 - February 15, 16, 17 Full Challenge course weekend. 30 or so people expected plus 9 facilitators.
 - A person wants to video the challenge course to add to the camp website.
 - First weekend in April there will be a challenge course for Disciples.

 - Rev. Peggy Edge reported that it looks good.
- 14. Grants GVEC was a big success! Maybe GVTC, Wal Mart, Buc-ee's, Whataburger, HEB, Tyson
