- 4. Camp Director's Report Rev. Scott Miller
- We may need a new pump for the lift station (Approximately \$5,000). We may be insured. It was thought that we would be prudent to get a second opinion about how to best make this repair.
- Cell phone booster in Welcome Center is in and it works.
- Much was accomplished on the last workday including Wi-Fi in the Lodge, hedges trimmed, and replaced boards on the Lodge dock.
- Job fair at UTSA was slow. No significant leads for an intern from this yet.
- We are waiting for cash to move forward on replacing the AC units in the Lodge.
- We have received about \$3,000 as a result of Scott's letter sent to congregations concerning the AC grants.
- We are waiting on rain to get the road signs finalized for printing.
- May need to repair or replace water heater in Lodge.

- Scholarships for camp are in place. There are no funds in the account yet. Funds are on the way. Ad-hock committee will continue to discuss.
