POSITION SUMMARY:

The fire/rescue technician is an important member of the event medical division team providing services including: extinguishing and preventing fires, providing emergency medical care supporting the EMS crew on site, providing all duties within company operational policies and regulations.

QUALIFICATIONS:

- Valid Emergency Medical Responder Certification
- Valid CPR level C for HCP
- Class G driver's license with less than 7 demerit points or prohibition from driving under the criminal code. (Class DZ preferred)
- Experience as a volunteer firefighter or professional firefighter in the province of Ontario
- Active member of a volunteer or professional fire department in the province of Ontario

POSITION RESPONSIBILITES:

- 1. Respond to fire and medical emergencies at the event assigned.
- 2. Drive vehicles during an emergency.
- 3. Applying proper fire fighting and rescue techniques needed to control and/or extinguish fires prior to the arrival of community fire department personnel.
- 4. Assisting in clean up and returning equipment to service after an emergency.
- 5. Keeping equipment in good condition.
- 6. Attending training as required.
- 7. Working with EMS personnel in the provision of event medical coverage where necessary.
- 8. When working in an EMR only role, follows all of the position responsibilities outlined in the emergency medical responder position description.
- 9. Completes reports and paperwork necessary to document and detail the particulars of the emergency call/shift.
- 10. Undertakes daily inventory responsibility, accountability and functioning of equipment, vehicle safety checks, supplies and medications.
- 11. Ensures operational quality assurance and quality improvements.



- 12. Promotes positive working environment through Professional conduct with clients, client family members, public and other emergency services.
- 13. Protects own health and health of others by adopting safe work practices, reporting unsafe conditions immediately, and attending all relevant in-services regarding occupational health and safety. Follows all guidelines for employees and employers as legislated under the Ontario Occupational Health and Safety Act.
- 14. Demonstrates professionalism at community events by maintaining a professional appearance, providing appropriate supervision of the event and being ready to respond to any emergency that may arise.
- 15. Effectively communicates with the event organizers, event staff and other agencies at the event to ensure safe and appropriate coverage is provided.
- 16. Maintains current certifications as required
- 17. Maintains the required physical fitness for the position, as outlined in the operational guidelines.
