REQUEST FOR PRODUCTION

The Petitioner/Respondent, *, by and through the undersigned attorney, and pursuant to Rule 12.351, Florida Family Rules of Procedure, requests the Petitioner/Respondent, *, to produce the originals or copies for inspection and/or copying by the attorney for said Respondent at the Law Office of **BRIDGET HEPTNER**, **ESQ.**, 2560 Gulf to Bay Boulevard, Suite 250, Clearwater, Florida 33765, within thirty (30)/forty-five (45) days of the service date hereof, the following items:

- 1. Bank statements and canceled checks from any and all bank checking accounts owned by you, in your own name alone, or jointly with others, or held for your benefit, for the past three (3) years. Please have the checks arranged in numerical order, attached to corresponding monthly or quarterly bank statements and divided into groups according to account numbers.
- 2. Statement of accounts from any savings account or credit union accounts owned by you, in your name alone, or jointly with other, or accounts titled in other names but are held for your benefit for the past three (3) years.
 - 3. Federal income tax returns and W2 forms for the preceding three (3) years.
- 4. Copies of intangible personal property tax returns including all schedules for the past three (3) years.
- 5. Copies of any and all financial statements made by you or made on your behalf for any purpose during the three (3) preceding years, including copies of any applications for credit made by you during the past three (3) years.
- 6. Legal description of any real estate owned by you or jointly with others, or titled in other names, but which are held for your benefit or in which you have any interest.

- 7. Closing statements or sales statements, showing the purchase price, down payment and other pertinent financial information concerning any real estate owned by you during the past three (3) years in your name alone, or jointly with others, or titled in other names, but which are held for your benefit, or in which you have any interest at the present time.
