The Lincoln County Board of Commissioners is accepting sealed written bids from qualified contractors for the purchase of road resurfacing services for four Lincoln County roads, CR-262 Amity – Woodlawn Road starting at Hwy 220 and ending at Jinx Goldman Bridge 1.60 miles, CR-234 Beck Drive starting at Curry Circle and ending at End of Pavement 0.10 miles, CR-295 Shawnee Drive starting at Indian Road and ending at End of Pavement 0.09 miles, CR-274 Water View Drive starting at Sullivan Road and ending at End of Pavement 0.27 miles. Contract information, bid form, and other information are enclosed.

Your written and sealed bid must include at a minimum:

1. Completed attached bid form and bid schedule with a total cost of services.
2. A bid bond, or an irrevocable letter of credit, or a cashier's check in the amount of 5% of the bid amount payable to the Lincoln County Board of Commissioners from a company authorized to do business in the State of Georgia.
3. An authorized signature.

In addition, the successful contractor shall submit the following items within ten calendar days of written notification from the county of the bid award.

1. Proof of workers' compensation insurance.
2. Proof of general liability insurance in the amount of at least \$500,000 naming the Lincoln County Board of Commissioners as an additional insured.
3. Proof of automobile liability insurance in the amount of at least \$500,000.
4. A performance bond in the amount of the bid. The performance bond shall be payable to the Lincoln County Board of Commissioners from a company authorized to do business in the State of Georgia.

5. A payment bond in the amount of the bid. The payment bond shall be payable to the Lincoln County Board of Commissioners from a company authorized to do business in the State of Georgia.
  
6. Written certification that the contractor operates a drug free work place in accordance with O.C.G.A 50-24-1 through 50-24-6.
  
7. Written oath stating that the contractor has not restricted competitive bidding.
  
8. Signed contract (prepared by the contractor).

If you choose to submit a written bid on this service, your sealed bid must be marked, "Sealed Bid –Road Resurfacing RFP 18-003" and delivered to the Lincoln County Clerk's Office at 210 Humphrey Street, P.O. Box 340, Lincolnton, Georgia 30817 no later than 2:00 p.m. on Tuesday, October 2, 2018. All bids will be opened during a public bid opening at 2:00 p.m. on Tuesday, October 2, 2018 in the Commissioners Conference Room. The public is invited to attend this bid opening. No bids shall be withdrawn for a period of 60 days after the bid opening.

**Contract Information**

**The Contractor Shall:**

1. Verify the quantities of material needed.
2. Item unit price on the bid form shall also include the cost for the following items but not limited to:
  - all required traffic control material and work.
  - all erosion control material and work if applicable
  - driveways shall tie in to edge of pavement
3. Begin work on this project within 30 calendar days of written notification from the county to proceed.
4. Perform all work on this project in accordance with the Georgia Department of Transportation Standard Specifications, 2001 Edition as amended by supplemental specifications and contract provisions.
5. Maintain all aspects of the project including interim grading, drainage, and traffic control devices until the Board of Commissioners accepts the project.
6. Be responsible for all erosion control items covered and not covered in this contract and in accordance with O.C.G.A. Title 12, Chapter 7 entitled, "The Erosion and Sedimentation Control Act of 1975, as amended in 1989".
7. Repair any damage done to any existing driveways using like materials and construction.

8. Tie in any existing driveways to the newly paved road using the same roadway surface material shown in the contract. The contractor shall also prepare the driveway using GDOT specifications prior to resurfacing. The contractor shall build new shoulders as well as hydro seed any new dirt. The contractor shall include milling at bridges and at all concrete curb and gutter. The contractor shall only work on the county's right-of-way. This cost shall be included on the attached bid form.

10. Complete all work on this project by 5:00PM on December 21, 2018 or liquidated damages of \$200 per day will be assessed against the contractor. An extension of time may be granted by the Board of Commissioners beyond the December 21, 2018 deadline for inclement weather

1. Make the necessary arrangements with the utility companies and request them to relocate all utilities out of the limits of construction if applicable.
  
2. Pay the contractor within 30 days of completion. A five percent retainage of the bid amount will be withheld from the contractor until the Board of Commissioners accepts the project. This contract shall not exceed the contractor's bid amount without prior written approval from the Board of Commissioners. All extra work approved by the Board of Commissioners shall be paid on the basis of unit price as stated in the contractor's bid.
