2. As of September 26, 2014, No one (none) of the aforementioned parties cited; acknowledged and/or rebutted in writing to the Affidavit.
3. The Affidavit required from aforementioned parties cited; an appropriate response under oath or confirmation, upon full commercial liability and penalty of perjury registered in the Notary Office no later than TWENTY (20) days from the date stamp of the original certified mail, as indicated by the certified returned receipt numbers in this notice of default.

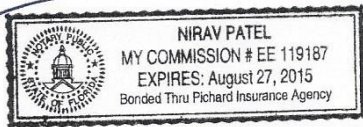
