It's been a busy week working for and with Islanders. Several motions and bills are in the works. One in particular, I intend to introduce, is a motion on Campaign Finance Reform that calls on government to "amend the Election Expenses Act, prior to the next general election, to remove the ability for corporations and unions to make contributions to political parties and candidates, and to set annual maximum limits for all contributions to political parties and candidates."

I expect a lively debate on this motion.

Brookvale Provincial Ski Park is now officially named Mark Arendz Provincial Ski Park. This honours PEI's great Paralympian and the six medals he won in Pyeongchang.

As well, in Summerside, a fully accessible park and playground will be built and named Billy Bridges Park for our silver medal-winning hockey player.

Q:

What is a citizens' assembly? A:

A citizens' assembly is "an independent, non-partisan assembly of citizens" that is convened to deliberate on complex issues of significant importance in society. They are made up of citizens that are randomly selected from the population in such a way as to be

## CITIZENS' ASSEMBLIES AND RURAL GOVERNANCE

Judge Ralph Thompson in the 2009 report of the Commission on Land and Local Governance recognized that in order to reform rural governance on PEI it would be essential to conduct a thorough public engagement exercise in order to "determine the consensus of Islanders". The Report also recognized that there are many challenges associated with the way rural PEI is currently governed and that this has real consequences for the long-term sustainability of our communities. There have been a series of attempts at rural amalgamation over the years on PEI. Currently, we are focused on the Three Rivers area. After several public meetings, plebiscites, and municipal votes a consensus has yet to be reached.

The Office of the Third Party is asking Government to review what it has learned from the difficulties in the current process and we've suggested creating a citizens' assembly to help find consensus.

Angus MacLean Building 175 Richmond Street Charlottetown, PE broadly representative of society (e.g. they are typically balanced across genders, geographic region, Indigenous representation, and other factors). This group of citizens examines issues by learning from experts, engaging the public, deliberating and discussing, and making collective decisions on the matter, including issuing recommendations to government.

Who is eligible to be a member of a citizens' assembly?

Typically all eligible voters are eligible to be selected as a member of citizens' assemblies, although elected officials and a few other people are normally excluded. A non-partisan chair (e.g. former judge, academic, etc.) is appointed by government to facilitate the assembly's work.
