Q&A

Q: What is the role of an MLA?

A: The role of Legislator involves understanding current laws, studying, discussing and then supporting or opposing the enactment of new laws. As a Representative of his or her constituency, a Member may voice concerns on behalf of constituents, represent viewpoints or intercede and assist in resolving problems. As a member of a caucus an MLA may be involved in working with and supporting caucus colleagues to achieve common goals, and developing expertise in given subject areas.

An MLA may also serve as a Cabinet Minister or Critic. Members of the Legislative Assembly divide their time between their constituencies and their work in the assembly. An MLA's duties will vary, depending on whether he/she is a member of cabinet, a member of an opposition party, an independent member, or a government backbencher. Members spend much of their time researching and asking questions in the House regarding their constituencies and critic areas. Members also present petitions, motions, and private members' bills to the House. MLAs also serve as members of various standing committees. Committee membership is allocated to the political parties in approximately the same proportion as their representation in the House.

MLAs spend time helping their constituents on a variety of issues: individual problems, navigating government departments and agencies, and issues specific to the district.

In May 2016, the Premier stood in the Legislature and promised to table legislation that would ban corporate and union donations. In December 2016 he announced that he had reconsidered the issue and would not be banning corporate and union donations. The federal government, Nova Scotia, New Brunswick, Quebec,

Manitoba, Alberta, and British Columbia, have legislation to ban corporate and union donations. The Third Party " strongly believes that these types of donations have a corrupting influence. I cannot accept that it is merely a coincidence that some of the biggest donations to the two largest political parties on PEI come from construction companies, accounting firms, legal firms. The one thing these donors have in common is that they are businesses that either receive millions of dollars in government contracts, or they are regulated by government." - Peter Bevan Baker, November 30th, response to the Speech from the Throne.
