Q&A

Q: What is a marine protected area?

A: A clearly defined geographical space, recognised, dedicated and managed, through legal or other effective means, to achieve the long-term conservation of nature with associated ecosystem services and cultural values' There are many kinds of marine protected areas that meet this broad definition, and which can have a wide range of conservation objectives. Such objectives can include:

- To ensure the long-term viability and maintaining the genetic diversity of marine species;
- To protect depleted, threatened, rare or endangered species;
- To preserve habitats considered critical for the survival and/or lifecycles of species, including economically important species;

- To provide for the continued welfare of people affected by the creation of marine protected areas:
- To facilitate the interpretation of marine and estuarine systems for the purposes of conservation, education and tourism;
- To accommodate with appropriate management systems a broad spectrum of human activities compatible with the primary goal in marine and estuarine settings.

OTP Motion 37 Calls on government to promote a major study of our entire gulf marine ecosystem, and consider establishing a Marine Protected Area.
