Q&A

Q: Who holds government to account?

A: When sitting in the house or on legislative committees, all private Members of the Legislative Assembly (those who are not Cabinet Ministers) have a responsibility to hold government to account. 'Holding government to account' is most often assumed to be the responsibility of the opposition MLAs but in reality it is the responsibility of all private MLAs. That is why government members are allocated two questions in question period every day. That is their time to hold government to account. As well, private MLAs sit on legislative standing committees. Committees and up until recently, that is why Cabinet Ministers did not sit on committee.

4 EASY STEPS TO FIX BILL 38

Step 1: The main objection to Bill 38 is that it unnecessarily restricts those who are for or against change from promoting or even publicly speaking about their position from the time the bill is proclaimed, presumably later this week, until the next general election, presumably in October 2019. We could easily fix this by only restricting activities during the election writ period. Step 2: simply state that the next government has a clear mandate to implement whatever the result is of the referendum. Step 3: Fines should be reduced from \$10,000 to a level similar to the current fines in the Election Expenses Act, which are \$2,000. Step 4: Seek a written legal opinion on whether the revised legislation could stand up to a constitutional challenge before Bill 38 comes into effect.

Peter and Hannah will be introducing a series of amendments to make these changes, and hope all MLAs will support them.
