**MEFC Agreement, Waiver & Release of Liability**

Each Rider, Personal Vehicle Driver and Accompanying Passenger **MUST** sign an individual waiver

NOTE: MEFC in this release refers to Mitchell Evangelical Free Church and Tour de La Grange refers to all related events occurring before, during and after the bicycle ride.

I, the undersigned, know and understand that Tour de La Grange involves potentially hazardous or dangerous activities. I participate in Tour de La Grange out of my own free will and choice. In choosing to attend Tour de La Grange, I fully accept and assume all risks, whether before, during or after Tour de La Grange and hold harmless MEFC, Tentmakers Bible Mission, and their subsidiaries and affiliated entities, Tour de La Grange sponsors and participating clubs, public and civic entities, communities, public and private schools, colleges and universities, religious and related organizations, MEFC and Tour de La Grange officials, emergency and support personnel, volunteers and their representatives, and the officers, directors, employees, representatives, agents or assigns, persons and entities that provide event recommendations, advice or services (hereinafter "Tour de la Grange affiliates") whether before during or after the Tour de La Grange. These risks include, without limitation, physical injury, mental injury, emotional distress, trauma, sickness, illness, death, contact with other participants, equipment failure, inadequate safety equipment, traffic, contact with motor vehicles of all types and descriptions, collision with other riders or fixed objects, the conditions of the road, camping and negligence of others. I understand that I may be camping outdoors during Tour de La Grange and this necessarily involves being exposed to the elements including risks of unpredictable and possibly dangerous weather conditions including thunderstorms, rain, hail, lightning, wind and tornadoes either during the day or at night. All risks are known and appreciated by me and I waive any and all specific notice of the existence of them. I assume and will pay my own medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorize such expenses. I authorize the use and release of personal and medical information in connection with any medical services provided to me.

I realize that Tour de La Grange requires physical conditioning. I represent that I am in sound medical condition capable of participating in Tour de La Grange events without risk to myself or others. I have no medical impediments, which would endanger others or me. I understand that a situation may arise during Tour de La Grange which may be beyond the control of the sponsors, promoters or organizers or may arise from negligence by them or others. I will be solely responsible for the condition and adequacy of my bicycle, safety gear and riding equipment. I will ride safely within the limits of my own abilities, my equipment and the riding conditions and in a manner so as not to endanger either myself or others.

Knowing these facts and in consideration of my entry acceptance, admission to and/or participation in Tour de La Grange, I, for myself and anyone acting on my behalf and for my heirs, devisees, legatees or assigns, hereby release, waiver, discharge, covenant not to sue and agree to hold Tour de La Grange, MEFC and affiliated entities, MEFC sponsors, and participating clubs, public and civic entities, communities, public and private schools, colleges, and universities, religious and related organization; MEFC and Tour de La Grange officials, emergency and support personnel, volunteers and their representatives; and the officers, directors, employees, representatives, agents, persons and entities that provide event recommendations, advice or services relating to matters such as route selection or maintenance, risk management, safety and first aid, and successors of all of the above, harmless from any and all claims, demands and actions of any and every kind I have, may have or may hereafter accrue against the released parties directly or indirectly arising out of Tour de La Grange. My waiver and release of all claims, demands, actions and liabilities shall include without limitation, any injury, damages or loss to my person or property which may be (a) caused by any act, or failure to act, by the above-identified persons and entities, including without limitation, their negligence, and/or (b) sustained by me before, during or after Tour de La Grange. I will abide by all Tour de La Grange rules and regulations. I understand that my name, address, photograph, voice and/or likeness may be used in promotional or advertising materials by Tour de La Grange and its licensees. I consent to such uses and waive the right to privacy or publicity I may have in connection with those uses. I also waive any privacy rights that may result from disclosure of information about me, including without limitation, in connection with provision of any medical services by Tour de La Grange sponsors and organizations.

I agree to abide by all oral and or written requirements established for vehicles accompanying Tour de la Grange, recognizing that Tour de la Grange affiliates are not insurers of the safety or protection of my vehicle or its drivers. I agree that during the Tour de la Grange ride, I will abide by all local, state and federal laws with regard to the operation and use of my vehicle or RV and will hold harmless Tour de la Grange affiliates from any infraction or violation thereof. I agree that Tour de la Grange affiliates shall not be liable for any harm, loss or damage that I may incur while participating.

I further agree to indemnify and hold the parties released above harmless from any all losses, damages, claims and expenses, including attorney's fees, arising from or relating in any respect to my attendance and/or participation in Tour de La Grange or my breach of this agreement. If I am a minor, my parent or guardian also is signing on my behalf. We both agree to be bound by the terms of this agreement, waiver and release.
