TERMS AND CONDITIONS

Please read the following Terms and Conditions carefully and sign in the space provided below to indicate your agreement to these terms.

ACCOMMODATIONS: Hotels based on twin occupancy with bath. Single-room supplement for an additional fee of \$890.

MEALS: Hearty breakfast and dinner provided daily in Israel (no meals provided in the U.S. or en route). Participants are responsible for any extra charges for beverages not included in menu of the day. If a participant chooses not to have a meal, there will be no refund for unused meals.

LAND ONLY: To allow for maximum flexibility (individual departure/ return cities, European stopovers, use of Frequent Flyer points, etc.), this will be a land-only package. Participants will be responsible for arranging their own domestic and international flights and will be given specific instructions for our in-country rendezvous. Participants are solely responsible for any costs related to domestic or international flights, transfers, fees, or schedule changes. Passengers will be responsible for any additional expenses (food, lodging, etc.) incurred in the event of a flight cancellation or delay.
