I understand after that through the Automatic Payment Plan (checking account only), I will pay by my chosen payment schedule on the 1st of each month. If I go on vacation, I will be required to pay the tuition due for the month(s) or withdraw from the program.

- 3) Parents will be held responsible for reasonable attorney fees and collection costs necessary for the collection of any fees not paid by their due date.*
- 4) Families with delinquent accounts will not be allowed to re-register for the following school year.*
- 5) If the terms of this contract are not met, St. Paul's Littlest Angel Preparatory Preschool has the right to notify other schools.*
