R COST SAVINGS

- Formulary developed and managed by Clinical Consultant Pharmacist in collaboration with your Medical Director and physicians
 - Pharmacy determines the therapeutic alternative

- o Med Cost Threshold
 - You set the threshold for high cost items
 - Items are not dispensed without your authorization so no surprise high dollar charges
- o Rx Interventions Program offered
 - Clinical Pharmacist Consulting for new admissions, re-admissions, short stay residents, medication changes, dose changes, etc.

- o Split billing
 - Only meds used during Medicare Part A stay are billed to Part A per census report = cost savings
 - Non-Part A medications and OTC's billed to third party insurance or private pay
 - Prior Authorizations resolved with facility assistance *before* billing
 - Notification to facility for non-covered items to obtain authorization before dispensing
- Reasonable pricing on OTC's and private pay drugs cost savings to the facility and the patient

B DRUG DESTRUCTION PROGRAM

- o Drug destruction system offered for drugs that are expired, discontinued or no longer needed
- Reverse Distributor program using compliant procedure per GA Board of Pharmacy

- o Low cost resource available for red container biohazard waste destruction
