- o Orders and refill requests filled and delivered same day within cut off parameters
- o Electronic refill ordering for non-cycle meds with use of electronic MAR
 - Reduces staff time pulling stickers and faxing refill requests
 - MD may escribe all orders directly to the pharmacy
 - MD may escribe CII's directly to the pharmacy if MD is certified for electronic CII's no paper Rx required
 - Eliminates lag time writing paper Rx and pick-up, so there is no delay in receiving medication

PACKAGING

 - 7-day cycle available for non-controlled oral solid medications and OTC's
 - ✓ Reduces staff ordering time by approximately 70%
