

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.costreportcpa.com, and NMP Professional Services, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to NMP Professional Services, Inc. include www.costreportcpa.com and NMP Professional Svcs. Collection of your Personal Information
