The common council for the city adopts by reference the following chapters of the Oregon Revised Statutes: 131, 132, 133, 135, 136, 137, 138, 142, 144, 146, 147, 151, 153, 156, 157, 161, 162, 163, 164, 165, 166, 167, 169, 419A, 419B, 419C, 47 1, and 475 of the 1993 Edition of the Criminal Code of the Oregon Revised Statutes. 9.08.010 Minors on Streets at Night.

It is unlawful for any person under eighteen (18) years of age to be or remain upon any street or alley or other public place in the city between the hours of ten (10) p.m. and four a.m., unless such person is accompanied by a parent or guardian, or other person having custody of such minor or unless in the performance of duty directed by such parent or guardian or other person having custody or unless such person is in lawful employment making it necessary to be in such places after ten (10) p.m. Ord. 175 § 1, 1991; Ord. 193 § 1, 1995)

9.08.020 Permitting Minors to Violate Curfew.

It is unlawful for anyone having the legal care and custody of any person, as described above to allow or permit such minor to go or be upon any public street, alley or other public place in the city in the night time as restricted in Section 9.08.010, except in case of necessity. (Ord. 175 § 2, 1991)

9.08.030 Detaining Minor.

Every member of the police force while on duty is authorized to detain any such minor willfully violating the provisions of Section 9.08.010 until the parent or guardian of the minor shall take him or her into custody; but such officer shall immediately upon taking custody of the minor communicate with the parent or guardian. (Ord. 175 § 3, 1991)

9.08.040 Delinquent or Mendicant Minors.

If it shall appear that any minor taken into custody for a violation of Section 9.08.010 is growing up in mendicancy or vagrancy, or is incorrigible, for lack of a proper parental care or has no home, proper proceedings shall be taken to have such minor placed in the care of a state institution as provided by state law.
