This is the summary annual report for the E Light Electric Services, Inc. Employee Benefit Plan, EIN 84-1477330, Plan number 501 for the period August 1, 2016 to July 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has a contract with insurance carriers to pay health, life, dental, vision, STD, LTD, AD&D and EAP claims incurred under the terms of the plan. See attached list of carriers. Total premiums paid during the plan year were \$1,415,353.

Because they are so-called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending July 31, 2017, the premiums paid under such "experience-rated" contracts were \$93,248, and the total of all benefit claims paid under these "experience-rated" contracts during the plan year was \$65,938.
