TOY SHOW EXHIBITOR:

- We are looking forward to a “super show” this year, Please review the following guidelines:
- **Absolutely, no early teardown will be permitted.**
- **Setup is Friday, Nov 1st, 2019 from 3pm. (no earlier) until 7pm. And Saturday 7am to 8:45am. Event opens at 9am Saturday, November 2nd, 2019** and all exhibitors are to be ready to sell.
- ***Tables will be resold at 8:45 am Saturday if unoccupied by the dealer.***
- **All Floor shelving must be approved by show promoters** before setting up.
- **Don't move tables until approved** by show promoters.
- **After setup**, exhibitors are to park vehicle(s) & trailers. **ALONG THE FENCE NOT IN THE MIDDLE OF PARKING LOT OR NEXT TO THE BUILDING! Please ask where to park,** Due to the limited parking for patrons.
- Exhibitors are to **pick up there trash** and **breakdown any boxes they are leaving behind.**
- Exhibitors are to **furnish bags** for the customer's purchases. Also, bring your own **table covers for displaying**, as well as extra covers to **cover tables** at night. **You may bring your own chairs.** The building will be locked and secured overnight.
- Exhibitors will be responsible for Michigan 6% sales taxes on of all their sales. Every dealer is responsible for reporting his/her own sales tax collected in the state of Michigan.
- Please feel free to make copies of the “**2019 TOY SHOW**” flyer to place at various businesses in your area (bulletin boards, Laundromats, video stores, etc.). Should you need additional copies, please let me know. In addition, contact me with the name of your local newspaper, radio station, etc. and we will run ads for the event.
