Rule 4.3.6 WBRA Open races may accept late entries for a \$10 late fee and they will run at the bottom of the draw in the order of entries received if the Open has filled during pre-entry time. If the Open has not filled during pre-entry time, there will be no Open race. The acceptance of late entries is up to the discretion of the race committee per the race approval submitted. The late fee of \$10.00 to be paid split \$5 to WBRA \$5 to the producer. Open entries will be considered final as of callbacks and Open entries must pay their entry fee even if they draw out or turnout the day of the race.

Change to:

WBRA Open races may accept late entries for a \$20 late fee and the race producer will determine if they are to run at the beginning, end, or fill a hole in the draw left from turnouts, vet outs, etc. If the Open has not filled during pre-entry time, there will be no Open race. The acceptance and placement of late entries is up to the discretion of the race committee per the race approval submitted. The late fee of \$20.00 to be paid split \$10 to WBRA \$10 to producer. Open entries will be considered final as of callbacks and Open entries must pay their entry fee even if they draw out or turnout the day of the race within 5 days of the race.

Rule 9.1.2 Horses must be nominated before the Novice race (with the person handling the race, who in turn sends the information to the Novice Director) or one may nominate with the Novice Director prior to the scheduled race by mail. A \$20.00 registration fee and a completed novice registration form are required for each horse nominated before points count toward standings.

Change to:

Horses must be nominated before the Novice race (with the person handling the race, who in turn sends the information to the Novice Director) or one may nominate with the Novice Director prior to the scheduled race by mail. A \$25.00 nomination fee and a completed novice registration form are required for each horse nominated before points count toward standings. A minimum of \$100.00 in sponsorship money must be obtained for each nominated novice horse and postmarked to the treasurer, within 90 days of nomination date or any monies earned shall be forfeit and nominated novice horse shall be dropped from standings. Sponsorship money shall be sent directly to the WBRA treasurer to be deposited.

Rule 10.1.2 Girls 12 and under are eligible for the Junior Division. Girls between the ages of 13 and 18 are eligible for the Youth Division. Age is determined as of October 1st of the given year. A copy of the member's birth certificate must be provided within one month after nomination. Any Youth/Junior member wishing to compete in the Open Division or nominate a horse in the Novice Division must pay the difference between the Youth/Junior dues and the full dues (additional \$20.00) and applicable nomination fees. A Youth/Junior membership does not affect the Rookie status. Once a member pays the full membership that will be her rookie year.

Change to:

Girls <u>and boys</u> 12 and under are eligible for the Junior Division. Girls <u>and boys</u> between the ages of 13 and 18 are eligible for the Youth Division. Age is determined as of October 1st of the given year. A copy of the member's birth certificate must be provided within one month after nomination. <u>Youth/Junior members</u> wishing to compete in the Open (girls only) Division or nominate a horse in the Novice Division must pay the difference between the Youth/Junior dues and the full dues (additional \$20.00) and applicable nomination fees. A Youth/Junior

membership does not affect the Rookie status. Once a member pays the full membership that will be her rookie year.

Chapter 11

Chapter 11 Futurity Division

- 11.1 The Futurity Division is open to any horse that is five years old or younger as January 1 of the calendar year. Name and papers must be submitted at the time of nomination. If unregistered, must provide a proof of age with a veterinarian's affidavit.
- 11.2 Futurity horses nominated cannot have entered any barrel race prior to December 1st preceding their Futurity year, with the exception of exhibition and time only runs. Futurity horses may compete in any races after December 1. Failure to comply with this rule means forfeiture of nomination fee and elimination from the division. Horses may compete in events other than barrel racing at any time.
- 11.3 There will be a \$100 nomination fee for each horse nominated into the Futurity Division. Multiple nominations of eligible horses is allowed. Must be a full WBRA member in order to nominate. Nomination fee must be paid before points will count.
- 11.4 All horses subject to veterinary inspection at the discretion of the Futurity Director or the Board of Directors.
- 11.5 All money won at WBRA approved races and rodeos will count for year- end standings. The Futurity director will keep a record of standings.
- 11.6 There will be year- end awards for the top 3 Futurity horses, as of September 30, to be presented at the annual WBRA finals banquet. The Futurity champion will be awarded a trophy saddle, as money allows.
- 11.7 Must enter and compete at 9 WBRA prime races to be eligible.
