Payment: A Reservation of \$50 per cabin due by April 15, 2019; Then 1st Full Deposit of \$150 per person is due May 12, 2019 along with names of cabin mates and Protection Insurance. Final Balance is due July 12, 2019. Reservation deposit amount to be paid by check to Great Expeditions; *1st and final payment may be paid by check or charged to major credit cards. * Credit Cards are charged directly through Carnival Cruise Lines.*

Cancellation: Reservation deposit completely refundable, no fee, till May 11, 2019, First Deposit is completely refundable until July 11, 2019 less a \$25 per person cancellation fee. Final deposit is refundable up to August 30, 2019 less a \$50 per person cancellation fee; after August 30, 2019, non-refundable. Additional provider exceptions noted here: Great Expeditions reserves the right to cancel any guest for non-compliance of schedule payments, nonpayment of scheduled deposits or final cruise payment without written notification of cancellation prior to due date will result in loss of deposit and fees.
