

**MINUTES
EAST NOTTINGHAM TOWNSHIP
VACANCY BOARD
SPECIAL MEETING
DECEMBER 21, 2006**

The Special Meeting of the Vacancy Board of East Nottingham Township was held in the Township Building on December 21, 2006. Those present were Chairman of the Vacancy Board Joe Scheese, Chairman of the Board of Supervisors Leo M. Levandowski, Vice-Chairman Charles D. Shelton, Secretary Pat Brady and numerous guests.

The Meeting was called to order at 7:00 P.M..

The Pledge of Allegiance was led by Vice-Chairman Shelton.

Appoint Secretary for Vacancy Board- Motion made by Vice-Chairman Shelton seconded by Chairman Levandowski to appoint Pat Brady as Secretary at a salary of \$50.00.

Proof of Meeting Advertisement- Chairman Scheese read the advertisement.

Introduction of Board Members- Chairman Scheese stated he was appointed to be the Chairman of the Vacancy Board at the January 2006 Organizational Meeting.

Comments on Procedure- Chairman Scheese stated , we are going to entertain candidates names for filling the vacancy that was generated in November by Thom Olivieri's resignation.

Chairman Scheese asked the guests in the audience if they would like to be nominated or like to nominate someone, please step up and state your name and address.

No nominations were made.

Chairman Levandowski stated the conversation today between the Secretary and Thom Olivieri should be made a part of the meeting. Chairman Levandowski handed it over to Vice-Chairman Shelton who handed it over to Pat Brady, Secretary.

Pat Brady stated she was instructed by Vice-Chairman Shelton to call Thom Olivieri and inform him of the Vacancy Board Meeting this evening . Let him know the Supervisors were considering to appoint Thom as Supervisor for a term of one year. If so, would he accept this, yes or no. Thom Olivieri's response was, I don't have to accept being appointed, I am still a Supervisor of the Township, I do not have to be appointed. Pat again said, I need a yes or no, Thom said I can't give that to you, I am still a Supervisor.

Glenna Jordan asked what legal advice was given.

Chairman Levandowski stated the legal advice was to look at candidates to fill the position. They feel we have a vacancy and we have to fill it.

Joe Bauer asked then Thom's revocation of resignation is not accepted? Chairman Scheese responded, there was no action taken.

Chairman Levandowski recommended Mike Miller. Chairman Levandowski has interviewed Mike and feels that Mike is more than qualified to fill the chair for the remainder of the term to December 31, 2007. He has attended many meeting, has a lot of input, he has added helpful information to our meetings, proactive with the Boards various projects that are going on and with his background in construction, I feel very comfortable in recommending him. He's aware of budgets, time constraints and time management.

Rick Orner asked if he has any self serving interests in the Township? Chairman Levandowski responded, no, not to his knowledge.

Chairman Scheese offered Glenna Jordan as a candidate for the vacancy. Chairman Levandowski stated to Glenna , is she aware that if she becomes Supervisor she will have to resign from Auditor. Glenna responded, yes she is aware.

Chairman Scheese offered Alvin Miller as a candidate for the vacancy. He has served on the Planning Commission and has been around for a very long time.

Vice-Chairman Shelton stated he is going to support Mike Miller

Chairman Scheese stated that the Board feels strongly that since Thom Olivieri is a democrat, the Board should appoint a democrat in the seat. All these people we have talked about are democrats.

Rick Orner stated Thom Olivieri sent an email back in January to a candidate running for office, asking the candidate if he would be interested in taking his position if he resigned. Rick Orner doesn't feel Thom can make up his mind.

Motion made by Chairman Levandowski seconded by Vice-Chairman Shelton for Mike Miller to take the vacancy until December 31, 2007.

Chairman Scheese advised they will try to swear Mike Miller in on Saturday, December 23, 2006 or as soon as possible and it does not have to be done publically.,

Gene Turns asked why Mike Miller is getting sworn in quickly. Chairman Levandowski responded, the seat is vacant now and we have to fill it as soon as possible.


Recognition of Visitors- None




