

**MINUTES
EAST NOTTINGHAM TOWNSHIP
PLANNING COMMISSION
SEPTEMBER 27, 2004**

The Regular Meeting of the East Nottingham Planning Commission was held in the Township Building on September 27, 2004. Those present were: Chairperson Marianne Russo, Vice-Chairman Joseph R. Bauer, Alvin Miller, Michael Rebert, Clifford Lee, Thomas J. Olivieri, Ron Ragan, Andrea Hingley, Secretary Pat Brady and numerous guests.

The Meeting was called to order at 7:07 P.M. by Chairperson Marianne Russo.

The Pledge of Allegiance was led by Vice-Chairman Joseph R. Bauer.

Motion by Chairperson Marianne Russo to make three changes in the agenda. Add Hickory Hill Treatment Plant allowing a brief presentation and deleting items #7, Darlington Hunt IV and deleting #8, Brightwell Reserves..Motion by Thomas Olivieri to approve the revised agenda, seconded by Clifford Lee

Jonathan Lapp property will be preserved and is approximately 92 acres with a fair amount of agricultural land. Approximately 30% open space with the bulk around the perimeter. All agreed this is a very interesting concept. Spencer Address requested to meet with Ron Ragan over the next month to go over the specifics and then come back next month and give the next level of details.

Chairperson Russo stated that the Secretary is going to request extensions for the following: Clyde Cameron, James Mark, Liz Miller Farm, Hickory Hill, and Woods at Nottingham
