## **SECOND COPY Music for Adjudicator Reference is a Requirement**

Failure to provide second copy will result in the performance *piece* (not the performer) automatically defaulting to a non-competitive category for adjudication only.

No mark will be given.

Eligibility for award *may be affected* dependent on other performance pieces entered.

***If you are having difficulty locating a second copy we suggest you contact the publisher for permission to copy and present proof of permission in advance to festival committee.***

## **NO PHOTOCOPIES (copyright law applicable to performers *and* accompanists)**

If a performer or accompanist has a photocopy attached to original music for ease of page turning they will be allowed to use it only if *committee has been notified in advance and presented with proof of permission.*

If music has been downloaded from internet the committee must be *notified in advance and receipt of payment must be presented.*

## **TBA (To Be Announced) for entry selections will not be accepted.**

Entries submitted with TBA will be omitted from the program.

## **CHANGE OF PERFORMANCE PIECE ORIGINALLY SUBMITTED will not be accepted.**

If committee is notified at a later date of a change you will be advised to withdraw the entry which may affect eligibility for an award.

---

## **CANCELLATION OF PERFORMANCE PIECE(S)**

Notification of a withdrawal BEFORE performance session is appreciated as it delays a session while we needlessly wait for, or try to locate, a "no-show".

If you have an unexpected emergency on day of session please call the venue or the discipline contact.

Withdrawal of entries are strongly discouraged as adjudicators are hired and dates reserved for venues based on number of entries received.
