I wish to participate in the Rules of the Road Driving School Traffic Safety Education Program. I am willing to give the necessary time and effort in order to fulfill the requirements of this accredited course as prescribed by the Washington State Department of Licensing, and outlined in the Parent/Student Handbook. I understand that Rules of the Road Driving School (RORDS) is authorized by DOL to enter course completions to the on-line Department of Licensing system upon successful completion of this course. I understand that RORDS meets or exceeds all State requirements. This is an 8 1/2 to 9 week course. All course requirements must be completed within the course session dates. Service charges apply if the course is not completed within time allowed. Course must be completed concurrently within the next contiguous course session or you will be dropped from the program.

It is further understood that it is necessary to pay the full tuition...all but \$125 refundable if I withdraw prior to the second class session. Please make checks payable to "RULES OF THE ROAD DRIVING SCHOOL." NO refund will be granted after the beginning of the 2nd class or for any suspension, expulsion, and/or failing the program for any reason. Service charges may apply. See Parent/Student Handbook & Potential Service Charges for details. RORDS will enter Permit Waivers online 10 calendar days prior to the first day of class, per Washington State Law. No enrollment after 3rd class and no more than three absences during entire course session.
