TO THE EXTENT PERMITTED BY LAW, THE ABOVE NAMED OWNER HEREBY RELEASES THE CITY OF SELDOVIA, ITS ELECTED AND APPOINTED OFFICIALS, EMPLOYEES AND VOLUNTEERS FROM ANY AND ALL LIABILITY OR RESPONSIBILITY TO THE OWNER OR ANYONE CLAIMING THROUGH OR UNDER THE OWNER BY WAY OF SUBROGATION OR OTHERWISE, FOR ANY LOSS OR DAMAGE TO THE PROPERTY, EVEN IF SUCH DAMAGE OR OTHER CASUALTY SHALL HAVE BEEN CAUSED BY THE NEGLIGENCE OR INTENTIONAL MISCONDUCT OF THE CITY OF SELDOVIA, ITS ELECTED OR APPOINTED OFFICIALS, EMPLOYEES OR VOLUNTEERS.

ASSUMPTION OF RISK BY OWNERS OF BOAT

THE OWNER OF ANY BOAT SHALL ASSUME ALL RISK OF DAMAGE OR LOSS TO HIS PROPERTY OF ANY KIND WHILE IT IS WITHIN THE LIMITS OF THE SELDOVIA HAUL OUT AND STORAGE AREA. THE CITY OF SELDOVIA ASSUMES NO RISK ON ACCOUNT OF FIRE, THEFT, ACT OF GOD OR DAMAGE OF ANY KIND TO BOATS, PERSONS OR EQUIPMENT.
