CITY OF SELDOVIA **RESOLUTION 22-40**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SELDOVIA ACCEPTING AN ADDITIONAL AMOUNT OF \$178.57 IN AMERICAN RESCUE PLAN ACT OF 2021 (ARPA) FUNDS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE THE APPROPRIATE DOCUMENTS.

WHEREAS, Through Res. 22-02, the City Council authorized the City's acceptance of funds offered through the American Rescue Plan Act of 2021 (ARPA) - Coronavirus State and Local Fiscal Recover Fund Award to Non-Entitlement Units of Local Government (NEUS) from the Alaska Department of Commerce, Community, and Economic Development; and

WHEREAS, The City's ARPA funding allocation originally totaled \$66,382.87 to be delivered to the City in two tranches; and

WHEREAS, The first tranche of ARPA funding the City received from the State of Alaska totaled \$33,191.44 with the second tranche to be delivered approximately 12 months later; and

WHEREAS, Through Res. 22-41, Seldovia City Council has approved \$15,000 of the first tranche to be used for water and sewer infrastructure grant writing services; and

WHEREAS, Through Res. 22-31, Seldovia City Council has approved \$10,098.59 of the first tranche to be used for making improvements to the Multipurpose Room (Council Chambers) and Police Chief's office if the City is the recipient of 2022 Community Development Block Grant - Coronavirus Program funding; and

WHEREAS, Seldovia City Council will continue to appropriate any remaining ARPA funds through resolution; and

WHEREAS, The City of Seldovia received notice from the State of Alaska, DCCED/DCRA of an additional amount of ARPA funds being allocated to the City totaling \$178.57 with half of that amount being received immediately and the other half of that amount being received with the disbursement of the second tranche of ARPA funds; and

WHEREAS, This additional allocation increases the total amount of ARPA funding from \$66,382.87 to \$66,561.44.

NOW, THEREFORE, BE IT RESOLVED: that the City Council of the City of Seldovia accepts the additional amount of \$178.57 in American Rescue Plant Act of 2021 (ARPA) Funds and authorizes the City Manager to negotiate and execute the appropriate documents.
