OFFICIAL RULES

1. The entry fee is \$125 per boat, which includes two anglers and two T-shirts. Tournament merchandise (T-shirts, cups, raffle tickets, etc.) will be sold separately on a first-come, first-served basis. The Captains Dinner will be held at St. Paul's Parish Hall on Thursday, November 3, 2022; doors will open at 6:00pm, meal begins at 6:30pm. Each captain or the captain's designee must attend. No entries will be accepted after the Captains Dinner.
2. Tournament hours will be 6:30am (shotgun start from Bemis Bay) until close of Weigh-In. Weigh-In will start at 2:00 pm and end at 3:30pm. At least one participant from the team must be in line with fish in hand at St. Paul's Chapel by 3:30pm or the team will be disqualified. In the event of a tie, the earlier weigh-in shall win. NO FISHING ALLOWED UNTIL 6:30am Saturday, November 5, 2022.
3. All fishing will be done in the Magnolia River, Weeks Bay, Fish River, or the waters of Mobile Bay east of a line running north and south through the Middle Bay Lighthouse. Both live and artificial bait may be used.
4. FISH MUST BE CAUGHT ON THE DAY OF THE TOURNAMENT. **All fish must be caught with rod and reel in accordance with the current Alabama fishing rules and regulations.** The Speckled Trout slot limit for Alabama is 15" minimum and 22" maximum, with one fish over 22" allowed among the six allowed per person, per day; the Redfish slot limit for Alabama, is 16" minimum, 26" maximum, with one fish over 26" allowed in the daily limit of five fish per person; as measured with a pinched tail on tournament weigh stick. **The "Total Speck Weight" prize is awarded for the total weight of up to 5 speckled trout caught during the tournament, excluding the fish registered to compete for the biggest speckled trout prizes.**
5. The Weigh Master's decision is final. NO CHEATING WILL BE TOLERATED.
6. Only ONE FISH per person is allowed to win in category. In the event of a tie, the earlier weigh-in shall win.
7. Junior Division (under age 12) prizes shall be separate.
8. For safety and legal reasons all entrants shall follow Alabama State Laws regarding the use of alcohol while participating in this tournament.
9. Any violation of these rules will result in disqualification of the entire team. Decisions on disqualifications will be made by the tournament committee officials and will be final.
10. Each contestant, evidenced by his/her entry in the tournament, does hereby release and agree to protect, indemnify and hold harmless, the tournament committee from and against any and all claims, demands, causes of action of any sort and damages resulting from an accident, incident or occurrence arising from, incidental to, or in any way resulting from his/her participation in this tournament. Each contestant hereby further covenants and agrees for him/herself, his/her heirs, successors and assigners, that they will not make and claim or institute any suit or action at law or equity against the committee, its agents, representatives, successors or assigns, arising out of injury or damage a contestant may suffer while participating in this tournament.
11. The lunker pot will be split 60:40 with St. Paul's Episcopal Chapel—the winner will receive 60 percent and St. Paul's will receive 40 percent.
12. This is a charitable event, and we appreciate all entries. Remember, the Tournament Committee officials have the final say on any conflict or problem. This is not negotiable.
