# Spanish Lakes Country Club Village Bocci Club By-Laws

## Article 1: Name

The name of the organization shall be Spanish Lakes Country Village Bocci Club.

## Article 2: Purpose

The purpose of the Bocci Club is to provide an enjoyable recreational activity for the members.

## Article 3: Membership

- A. All residents of SLCCV are eligible for membership
- B. Membership shall be on an individual annual basis from May 1 to April 30. Annual dues for membership shall be determined by the board each year and are to be paid prior to May 1. A member, who joins after May 1, will pay full annual dues.
- c. Only paid members shall be allowed to play games or to participate in meetings. Paid members and their guest may participate in social activities. Guests are limited to spouses or dates.
- D. There shall be two types of membership offered:
  - Team members a registered member of a team who participates on a weekly basis.
  - 2. Sub a member whose name is on the Sub List to substitute for a team member who is unable to play in a weekly game.

## Article 4: Meetings

Regularly scheduled meetings shall be held on the last Wednesday of the month during the playing season. The president may change the date and time as circumstances warrant.

#### Article 5: Elections

Each year the president shall appoint a nominating committee in January. The committee will present a slate of officers at the February meeting and any further nominations will be accepted from the floor. At this time, nominations will be closed. Elections will be coordinated by the nominating committee at the March meeting.

#### Article 6: Officers

- A. Newly elected officers shall take office at the April meeting.
- B. There shall be four officers as members or the Board.
- C. Should a vacancy occur on the Board, the president shall appoint a member of the club to serve the remainder of the term.

#### Article 7: Duties of Officers

### A. President

The president shall preside at all membership and board meetings and shall appoint such committees as deemed necessary.

B. Vice-President

The vice-president shall assume all responsibilities of the president in his/her absence.

## C. Secretary

The secretary shall keep a record of all Board and Membership meetings in the form of minutes. A copy of the minutes, approved or corrected, shall be available to all members.

#### D. Treasurer

The treasurer shall receive, disburse all types of funds and keep a record of all funds. A monthly report of the club's funds shall be provided at each monthly meeting, a copy of which will be available to all members.

## Article 8: Amendments

- A. All amendments to these By-Laws must be presented (read) at a monthly general membership meeting.
- B. The proposed amendment will then be voted upon at the next monthly general membership meeting.
- C. Approval of any amendment will require a two-thirds (2/3rds) approval vote of the members present at the meeting.
- D. The president may limit the discussion time on any amendment.
- Article 9: These By-Laws may not be suspended, in part or whole, at any time for any reason.
