C.O.P. EXPLAINED

(This letter is in response to one received from a resident in lieu of a donation to keep our patrols on the streets of SLCCV. The C.O.P. is NOT employed by the Wynne Building Corporation,)

Dear Uninformed,

The Citizens Observation Patrol is a community-based program that nationwide is associated with law enforcement departments and homeland security. All C.O.P. members driving official St. Lucie Sheriff's cars are volunteers. As the name implies, they are all citizens of our Spanish Lakes community. They have all been screened, background checked, and trained in a course conducted by the Sheriff's Office. They are driving as an extension of the St. Lucie County Sheriff and have no authority to enforce any Wynne Corporations regulations or community rules. They are the "Eyes and Ears" for law enforcement.

The C.O.P. groups have been in use within the United States for over 20 years and have been credited with making their communities safer. It has been found through many years of evaluation that the presence of the citizen volunteers on patrol have significantly limited crime in a community. As citizens of a community they have proven to be more aware of 'suspicious activity', because they know their community. Over the years the Spanish Lakes C.O.P. have actually observed crimes in progress and their rapid response of calling a Deputy to the scene has resulted in apprehension of criminals. Additionally, they have performed help with medical emergencies and saved lives.

Your C.O.P. is considered a great benefit to the Sheriff's department in that they provide a cost savings of your tax dollars. The patrols by volunteers provide a budget savings of hundreds of thousands of dollars annually and provide thousands of hours of "Eyes and Ears" in making our community safer. This savings allows the Sheriff to place more deputies on the streets and to purchase vital equipment. Studies show that the C.O.P. groups nationwide reduce crime by at least 20 percent. We hope this explanation provides you with an understanding of what the C.O.P. volunteers do for you and the community. Our request for the 15 dollar donation is to purchase gas for the

C.O.P. car. We certainly understand if you cannot afford to donate, as many in our community face financial hardships.

But we will continue to be the "Eyes and Ears" and to observe and report and help to keep you safe.

SCHOOL DISTRICT TAX INCREASE

In a few days, if you are a registered voter in St. Lucy County, you will receive in the mail a ballot from the St. Lucie County School Board. The School Board is asking for an increase in the millage rate for school taxes. This is a ballot that must be returned by mail or to one of the offices. The polls will not be open anywhere for voting.

Why is this so important? Because the vote being taken will be decided by a simple majority. If 100 people vote, and 51 of them vote yes, the additional school tax will be in effect immediately.

Those of us who rent the land our mobile homes sit on don't see the tax bill that shows that millage rate, but school taxes ARE included. We will see that tax increase in our lot rents eventually.

The Board is asking for a 1 mil increase which is a very real **15.2%** increase in school taxes. Does the school district really need the money? The district purchased a piece of prime real estate in St. Lucie West with insurance money, \$4-\$5 MILLION from Hurricane Irma. This land is now off the county tax rolls, and the new district office building is under construction, paid for with our tax \$.

Having followed county and school board goings on for the last 10 years, I believe the district could find money for raises within their budget. Teachers deserve a raise while district administration is top heavy with six figure salaries. With increases in new builds and property appraisals in the county, school tax revenue will go up as a result.

Vote your values, vote your conscience.

Letter from the Federation of Manufactured Home Owners of Florida

The following letter refers to legislation which was initially agreed to by FMO but has now been removed as a result of strong opposition from membership. Paramount among the concerns was the lack of due process for mobile home owners and no restrictions on the property owners/park managers to determine whether a property met the threshold of property maintenance. The serious concern was abuses for petty "violations" and a purely subjective standard for property maintenance determined solely by the property owner/park manager which would also include financial penalties imposed on the mobile home owner.

Greetings Everyone,

I am writing to inform you that House Bill 1023 and Senate Bill 1262 have been removed from 2019 Legislative consideration. This was agreed to by both FMO and FMHA and the sponsors of this Legislation.

To the opponents of these amendments I thank you for your well-articulated arguments. You reminded us that FMO was founded in 1962 by a group of residents who came together to protest an ordinance being considered by the St. Petersburg city council. To those who supported the bill and our Legislative sponsors I also thank you for your efforts and commitment.

Recent events such as the treatment of some of our officers and a discussion I had with a resident experiencing a problem addressed in this legislation caused me to consider how rules enforcement could be abused. I raised this concern with FMHA and explored amending the bills to remove this section. They expressed their disappointment and proposed removing the bills from consideration. Our Legislative Counsel also suggested it was too late to amend the Legislation.

In the end there were two major factors influencing this decision: 1) Consideration there were no checks in the process, who defines a violation, and how many times in a certain time frame can this happen. 2) Most importantly. The divisiveness this has created among our membership and mobile home owners.

CHOCOLATE BUNDT CAKE

What makes this cake special? It's gluten free, sugar free and low-carb. No one will ever know it has zucchini in it. Based on 16 slices, each has 228 calories, 7.7g/total carbs, 4.1g/net carbs, 7.3g/protein, 3.6g/fiber, 20.8b/fat. A ½ inch slice is about all I can eat at one time. Ingredients:

- 2-3/4 cups almond flour
- 1-1/3 cups sugar sub like Splenda
- ½ cup cocoa powder
- 2 tsp baking powder
- ½ tsp salt
- 6 large eggs
- ½ cup melted butter
- 2 medium zucchinis, 8" long
- 2 tsp vanilla extract

Directions:

1. Preheat oven to 325 degrees and lightly grease a Bundt pan.
2. Puree the zucchinis to give you one cup of liquid.
3. In one bowl mix together the dry ingredients.
4. In a second bowl mix together the wet ingredients.
5. Pour the wet ingredients into the dry. Mix well.

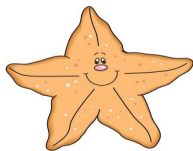

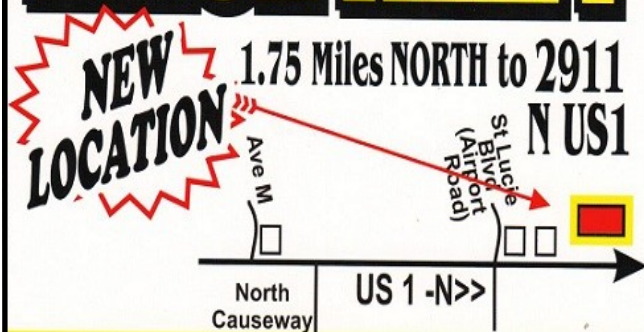
