ARC Reminder

We have a lot of new residents who probably don't realize that ARC approval needs to be obtained BEFORE making any external changes to your house or landscaping. Remember that ALL exterior changes to your property (paint, roof, windows, landscaping, doors, etc) must be approved by the ARC <u>prior</u> to starting the project. The appropriate forms can be downloaded from the website or a form can be picked up at the HOA office during business hours. The ARC meets each month on the first Thursday of the month and is noted on the calendar.


