**AN ORDINANCE AMENDING SECTIONS 38-111, 38-112, AND 38-113, CITY CODE; PROVIDING FOR THE PROHIBITION OF THE SALE OR USE OF POLYSTYRENE AND POLYPROPYLENE FOOD SERVICE ARTICLES AND PLASTIC STRAWS BY CITY CONTRACTORS AND TEMPORARY VENDORS ON CITY PROPERTY; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**
