I acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from my own actions, inactions or negligence, but the actions, inactions of others, the environmental conditions or from any of the equipment used. Further, I accept personal responsibility for the damages following such injury, permanent disability or death; and,
3. I knowingly and freely assume all risk, both known and unknown, even those arising from the negligent acts or omissions of others and assume full responsibility for my participation; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, hold harmless Upwest & Downeast Sea Kayak Guide Service officers, staff and volunteers and if applicable owners and lessors of premises used to conduct the activity, all of which are hereinafter referred to as "releases," with respect to all and any injury, disability, death, or loss or damage to persons or property, whether by law.
