

February 8, 2019 Letter to Supporters of RVRightsAZ

Support for updating RV guest parking issues in unincorporated areas of Pinal County started off with a community meeting in Arizona City on January 5, 2019. An amazing crowd of 400 people attended the gathering at the Freedom



Family Church. **Organizers were both astounded and delighted!** In order to provide awareness of the issues, both the current Pinal County current ordinance and the Citizen's Committee's revised draft were presented to attendees.

Additionally at that meeting we requested volunteers for assistance in going forward. The response was encouraging. Volunteers came forward and actions in the last month include the following:

- **Board of Directors** – A Board of Directors was selected and nine people now are serving. Directors include Helen Brown, Brian Guest, Laura Kleinjan and Narena Tomlinson of Maricopa and Bill Bailey, Ken Parsons, Dan Skiles, Eric Stephenson, and Rich Wist of Arizona City. Two meetings have been conducted with a third scheduled. Officers elected are Rich Wist, President; Ken Parsons, Vice President, and Brian Guest, Secretary/Treasurer.

To contact the Board of Directors send emails to board@rvrightsaz.com. The board has formed two committees: 1) Bylaws Committee and 2) Action Committee. Bylaws have been drafted and will be presented for approval at the next board meeting Feb. 12. To date the Action Committee has developed a handout brochure that publicizes a summary of the RV guest housing issue and provides links to the website and to Facebook. A petition that encourages the Pinal County Supervisors to support the Citizen's Draft for RV Guest Housing has also been approved. In the Maricopa area some board members are passing out the handout and getting petition signatures at local community events. The Arizona City Board members are preparing for Arizona City Daze on Feb. 23. There will be an entry in the Arizona City Daze Parade at 9 a.m. and they will have a booth for disseminating information.

Additionally the Board has approved and made an application to the Goldwater Institute for legal representation to assist in addressing the RV guest housing issue in unincorporated areas of Pinal County. The reply at this time from Goldwater Institute was that they have many applications and will let us know of their decision in the coming weeks.

Some of our members have heard comments like “No one has complained about me,” “If I sign a petition then “they” will be looking my way”, or “It’s not my problem.” If those individuals do not get involved in protecting our property rights what will happen if Pinal County passes a terribly restrictive ordinance that WILL affect everyone? Signing this petition is showing support; it is not a referendum which would require being a registered voter or citizen. Property owners, renters, tax payers and residents of Pinal County can show support.
