This 3-day workshop is designed for **probation officers/supervisors who oversee batterer intervention programs and/or supervise domestic violence offenders or oversee specialized family violence units**. In addition to learning about the unique dynamics of IPV, participants will learn how to interface more effectively with BIP's to increase program retention and evaluate strategies leading to reductions in violence. During this workshop participants will:

- ❖ *Develop strategies to reduce recidivism by improving offender accountability and leveraging community resources to address criminogenic needs;*
- ❖ *Synthesize the requirements of PC 1203.097 with an actual BIP curriculum model which utilizes evidence-based interventions and adult learning principles.*
