Current research is challenging batterer intervention programs to use evidence-informed interventions to combat the high attrition and recidivism common to many programs...but which intervention should we use? Principles of effective intervention (PEI's) is considered a “best practice” in criminal justice programming and has many components transferable to our work in BIP's.

Another Way...Choosing to Change combines the transferrable components of PEI's with traditional pro-feminist interventions and as a result has demonstrated significantly high rates of retention and low recidivism up to 8-years later (<25%).
