

PRIVATE INTELLIGENCE AGENCY [PIA] AGREEMENT

The client will not reveal or advise anyone that Legal Service of Process, and/or an investigation is being conducted, in order to ensure the safety of the Process Servers / Bail Enforcement investigators and preserve the quality of the [Serve / Investigation.]

Other _____ ANY and ALL future services rendered will be "added" onto CLIENT'S INVOICE. No additional services will be rendered unless ALL PARTIES agree. Any legal issues or disputes that may arise between CLIENT and [PIA], will be addressed in writing by either party FIRST allowing the dispute / conflict to be resolved before ALL PARTIES agreeing to settle dispute / conflict with a certified Mediator, Alternative Dispute Resolution [ADR] professional.

The client understands and agrees that the professional fees will be set at a FLAT RATE OF \$ _____ USD, plus any and all related costs. The client understands the Agency's fees, costs and expenses are non-refundable; regardless the outcome of the case.

The Client and the Agency agree that **ALL** Original services to be rendered will be paid upfront and in advance. The Client agrees to pay the Agency immediately for any "added" outstanding invoices such as [*skip-trace locate, stakeout or "other" additional services*] and funds are due to the Agency within **5 days**. In the case the client makes a stop payment on a credit card payment or a check; then the Agency will have the right to recover triple damages from the Client.

COMMUNICATION

The Agency will communicate with Client before, during and after the assignment regarding to updates and any issues / challenges that may occur and/or any additional services that may be needed to effect the service / assignment. If the client fails to communicate with the Agency, then the Agency has the right to cancel said agreement and demand immediate payment of all services rendered.

CLIENT AND FIRM RELATIONSHIP WITH CONFIDENTIALITY

The CLIENT understands that the AGENCY'S main goal is to protect CLIENT's rights, assets and interests. Therefore, the client has been truthful and didn't mislead the firm. The AGENCY has made No GUARANTEE, promise the success or outcome of any case. The client will hold the firm harmless from any damages or legal actions that might arise from the [service / investigation] of this case. In the event that the misleads the Agency, then the Agency will have the right to withdraw from the case without notice and will not provide any reports or evidence. Furthermore, the Agency will invoice the Client for the entire [service / investigation] including costs and the client will pay for the Agency's time, expenses and costs. The AGENCY will recognize and abide by client confidentiality privilege as long as the CLIENT will do the same. Therefore, ALL parties agree that ALL communication will be deemed confidential.
