



# OZTAG TOP UP

## Loss of Income Cover Per Team



Your team can now purchase top up loss of income cover for just \$110.00 (GST inclusive) PER TEAM!

The current cover you have under your Association covers you for death (including permanent disability) and non-Medicare medicals (i.e. physio, dental etc).

**It does not however include loss of income cover.**

You can now purchase this cover by completing the form (Registration) available from [www.oztag.com.au](http://www.oztag.com.au) in the 'TOURNAMENTS SECTION' and sending it back with payment (supply credit card details) to **Ausure Insurance Brokers**.

### Summary of Cover:

- Loss of Income: The amount payable is \$500 per week (or 75% Net Income Lost whichever is the lesser)
- The Maximum Benefit Period is 52 Weeks
- If you are a student the policy will cover Home Tutorial Expenses up to \$200 per week
- For non-income earners there is a Domestic Home Help benefit of up to \$200 per week
- The number of days before cover starts (the Excess) is 14 Days
- There is also an Injury Assistance and Parents Inconvenience Benefit for non-medical expenses (up to \$1,500)
