#### A Personal Message from the President

For those of you who still have not applied for their STAR abatement, that deadline is March 1, 2020. You don't have to reapply if you received the STAR exemption for the 2018-2019 tax year. New STAR applicants must register with NYS Tax Dept. to receive the credit. New applicants will receive the STAR credit in the form of a check DIRECTLY FROM THE STATE instead of a property tax exemption. Senior citizens may also be eligible for the Enhanced STAR, but you have to apply for it in order to receive it.

The NYPD NCO officers who serve our community, will be holding their meeting for our area on Feb. 18th. The flyer is in the back of the newsletter. These officers attended our last Annual meeting and addressed everyone's concerns. If you can, it would go a long way to forming a relationship with our neighborhood officers.

#### **ICE MELT DISTRIBUTION**

If you need ice melt for your stoops, please call the office. Save your empty coffee cans with the covers and bring them to the office so that we may put the ice melt in them for you to safely carry it home. Do not use rock salt on the property, as it will deteriorate the concrete.



#### **FINANCES**

The Financial Statement for the year ending 2019 is currently being worked on by the corporation's accountants and will be sent out with the Notice for the Annual Shareholders Meeting. We project the property's expenses to be near \$9,989,649 for 2020. A snapshot of some expenses includes:

**Fuel:** Gas Heat/oil is being projected to cost \$902.820.

Water & Sewer - \$652,307.

Repairs & maintaining the property's day-to-day physical needs is estimated to cost \$816,288.

**Operating Expenses** – exterminating, compactor repairs, vehicle exp. Garbage removal, licenses/permits, security etc. - \$341,800

**Insurance -** \$667,277

**Payroll** including workers comp, payroll taxes and employee benefits - \$ 1,400,654

Household Gas & Electric: \$969,200

**Financial Expenses** including Real Estate taxes, mortgage expenses - \$3,418,534

These are all projected costs and are subject to change. Although **this is not a complete list**, it shows the major costs associated with running Hyde Park Gardens. It also is impacted by the loss of our J-51Alteration credit which caused a \$271,423 increase in Real Estate taxes as well as increases in heating and electric.

#### RENOVATIONS REMINDER

We would like to remind ALL residents that <u>in</u> <u>order to do any home renovations you must fill</u> <u>out a renovation/alteration package</u>. The form can be found online at the Corporation's web site <u>hydeparkownerscorp.com</u>. As stated in the package, <u>by not getting permission</u> or removing all <u>construction debris</u>, <u>residents face a fine and possible legal action</u>.

#### DISHWASHER, WASHING MACHINE AND DRYER INSTALLATIONS

When installing a new dishwasher or washing machine or replacing the old unit you have, please make sure that your contractor installs the appliances with proper plumbing and electrical devices as well as a pan underneath. Check valves, shut off valves and GFI (grounded) electrical outlets are all required for these installations. You also must inform the Management office of the installation.

**CHECK VALVES** control the flow of both hot and cold water into the appliance and ensure that water will only flow in one direction and not back up into the main line. When this happens, your neighbors may experience a noticeable loss of water pressure when the appliance is used.

SHUT OFF VALVES will shut off water pressure to the washing machine or dishwasher when the appliance is not in use. This prevents unnecessary water pressure on the appliance hoses. When lines are continuously left "on" the water build up in the hose will shorten its life and deteriorate it. When this happens, there is a risk of the hose rupturing which can cause extensive damage to property and lower level apartments. Always make sure to shut off the water when leaving on vacation or long weekends.

**GROUND FAULT INTERRUPTER** (**GFI**) **OUTLETS** are to be used wherever there is a nearby source of water. Areas such as kitchens, bathrooms, washing machines and dishwasher outlets are some of the areas that these outlets are required. These outlets quickly shut off power when water comes in contact with the plug preventing shorts or electrical shocks to those nearby.

Hyde Park does not allow the installation of gas dryers. When the installation is discovered, the residents will be asked to remove the equipment immediately.

#### **ENERGY TIPS**

- Ensure gaskets around door seal tightly.
- Use microwave for cooking when possible.
- When cooking on the range, use pot lids to help food cook faster.
- If you are heating water, use hot tap water instead of cold.
- Remember to use the kitchen exhaust fan when cooking and turn it off after cooking.
- Let hot food cool before storing it in the refrigerator.
- Rinse dirty dishes with cold water before putting them into the dishwasher
- Replace any light bulb that burns more than one hour per day with its equivalent compact fluorescent or LED bulb.
- Turn off unnecessary lighting.
- Turn computers and monitors off when not in use.
- Make sure electric blankets are turned off in the morning.
- Turn large-screen TV's off completely when not in use.
- Turn off stereos and radios when not in use.
- Remember to turn off hair curling irons and hot rollers.
- Turn off coffee makers when not in use.
- Unplug battery chargers when not in use.



#### **AFTER HOURS CALLS**

After Hours Calls are **only** for emergencies. Repairs are made during normal business hours only 7:00a.m. to 3p.m.—after hours calls especially during the winter are for heating and emergencies only. If it's not an emergency, **do not call to have something repaired that can wait for the office to arrange with you.** 

The answering service only picks up calls made to the main number (718) 263-9680 during off hours. Please be sure to use only the main number if you need service.

**For Police emergencies**, call **911**. For quality of life infractions, it is recommended that you call **311** or contact the contact the 107<sup>th</sup> Precinct directly at 718-969-5100.

#### UPDATED SMOKING RULES

Smoking has become a real issue nationally, locally and here at Hyde Park. NYC has passed Local Law 17-506 stating that all co-ops, condos and rental buildings must have a published smoking policy. It also expanded its ban on smoking in common areas. Hyde Park has adopted the following policy and all residents and their guests must abide by this smoking policy or the Board will take such action that they deem necessary.

To sum it up, smoking is still permitted within individual apartments but the smoke is not allowed to infiltrate neighboring apartments, vestibules or stoops. Smoking in any form or of any product is not allowed in any of our indoor or our outdoor common areas which include vestibules, laundry rooms, management office, garages, nor within 10 feet of any window, clothesline areas, playgrounds, stoops and steps leading to apartments, nor any of the Corporation's benches.



#### **STORAGE ROOMS**

The storage rooms open at 7 a.m. and close at 9 p.m., weekends included. If you see a leak or an issue with the storage room please call the onsite office. To rent a storage facility on the property, please contact Bargold at: 212-227-4653 or 718-227-4653.

#### LAUNDRY ROOMS

The laundry rooms open at 8 a.m. and last wash is at 9 p.m.

#### FOR SHAREHOLDERS WHO PAY BY THEIR ONLINE BANK

For those residents who pay via online banking, <u>you</u> <u>should have it sent directly to the GPO box.</u> A new system was set up to accept payments without the maintenance, parking or rental slips as long as the correct 6-digit account number is listed on the check or it won't be properly posted. To enroll use your WebReg# located on the top part of the Stub portion of your bill. Please keep in mind that your payment will not be processed or show on your account until the following day. Payments made on Fridays, weekends or holidays will not show until the next business day. You can also schedule payments to be made on future dates.

#### MONTHLY PAYMENT OBLIGATIONS

Payments are due on or before the 1<sup>st</sup> of each month and are considered late if made after the 10th of the month. Payments may be made to the onsite office but <u>payments made on the 10<sup>th</sup> after 3:00p.m. will</u> be considered late.

\*PLEASE bring your payment stub when you make your payment at the onsite Management Office

Parking payments are due on the 1<sup>st</sup>. A \$10.00 late charge is assessed for parking payments made after the 1<sup>st</sup> of the month. A \$50.00 late charge is assessed for all residents who have not made their maintenance/rent payment as of the 10<sup>th</sup> of the month. Any resident in arrears for 3 months will be reported to a credit reporting agency.

#### AUTOMATIC DEBIT PROGRAM



The corporation offers a direct payment option so that the amount due each month on the maintenance, rental or parking account will be automatically deducted from the account you specified on the 5th day of each month. This is different than the online payment service offered by Metro. Anyone selling their apartment needs to make sure to fill out the cancellation to the ACH debit program 45 days before they anticipate closing. Contact the Management Office or go to the Hyde Park web site for the form.

#### **GARAGE UPDATE**



Residents who currently store items in the garage accommodations do so at their own risk as the cooperative assumes no liability as stated under the license agreement. Residents should also take note that if they are on the list to switch to a closer garage accommodation, that the transfer from one garage to another is to take place immediately. No additional time will be provided to transfer from one accommodation to another.

#### **IMPORTANT PARKING LIST NOTE**

Residents in arrears in their maintenance and or parking fees are placing their parking privileges in jeopardy of the corporation terminating their license agreement. Any residents on the parking waiting list in arrears at the time an accommodation becomes available, will be dropped from the list. There will be no notice sent to you asking you to pay the arrears and you will have to submit another application to start the process from the beginning. Parking is a privilege as there is not enough parking on the property to accommodate all of our residents. The corporation will not consider a resident in arrears for an accommodation.

#### TRASH PICK-UP REMINDERS

- Place your recyclable metals and plastics in the BLUE recycling bin for pick up each Wednesday morning. DO NOT PLACE RECYCLE ITEMS IN A SEPARATE BAG BEFORE YOU PLACE THEM IN THE BLUE CAN.
- Bundle or bag your recyclable paper products ad place alongside your garbage bins, not in the blue cans for pick up only on Wednesdays.
- As of Jan. 2015, electronics can't be discarded in the trash. Place them NEXT TO your trash can for pickup by our staff

#### PLEASE DO NOT PUT OUT BULK ITEMS ON THE WEEKEND.

There are just 2 staff members available who pick up only household garbage on weekends. Please arrange to have your bulk items removed privately. Our staff will not pick up appliances. All major retailers are able to make this accommodation.

ON WEEKDAYS, ONLY: Please put out all bulk garbage before noon for pick up.

\*\*If you replace your mattress, you must have the company remove your old mattress off the property. PLEASE DO NOT PLACE BULK GARBAGE BY THE CURB OR IT WILL RESULT IN A VIOLATION AND FINE BEING ISSUED BY THE SANITATION DEPT

#### What Is Not Accepted IN E-CYLE NYC

<u>Appliances</u>: If predominantly metal or rigid plastic, recycle these with other metal and plastic recyclables, otherwise discard as trash.







#### These electronics cannot be discarded in the trash.

- TVs:
- VCRs, DVRs, and DVD players;
- Cable and satellite boxes;
- Video game consoles;
- Computers, including small servers, monitors, laptops and their peripherals, such as keyboards, hard drives, mice, etc.;
- Printers and scanners;
- Fax machines; and
- Small electronics, including tablets, mobile phones and MP3 players.

#### **EXTERMINATOR SERVICES**



Exterminator Services are available free of charge to all residents. Please call the management office to be put on the schedule for service on one of these days:

- 1<sup>st</sup> Saturday of the month
- 3<sup>rd</sup> Wednesday of the month
- 4<sup>th</sup> Saturday of the month

The exterminator services the property between the hours of 12:00 noon and 3:00 p.m. On the 2<sup>nd</sup> Wednesday of the month, the exterminator comes to treat only boiler rooms, storage facilities, laundry rooms and other common areas in need of extermination services, not individual apartments.

If you suspect a bedbug problem in the apartment, we will have the exterminator check, free of charge, on any one of the three days listed in the box only. It is important that if you think you have an issue, that it be checked right away so that your issue does not become your neighbors' issue. Residents must use the corporation's exterminator for any bed bug issue to ensure that it has been taken care of properly and avoid spreading the issue to other buildings.



#### MYTHS & FACTS OF LIVING DONATION

#### MYTH

Living kidney donors cannot live a healthy life with just one kidney.

#### MYTH

Living kidney donors must be one of the recipient's family members in order to be a match.

#### MYTH

Living kidney donors cannot choose the person they want to donate their kidney to.

#### MYTH

Only adults under the age of 50 can donate a kidney.

#### MYTH

Donating a kidney is a dangerous procedure.

#### MYTH

Donating a kidney reduces the donor's life expectancy.

#### MYTH

Out-of-pocket expenses for the living donor will be costly.

#### MYTH

Living kidney donors will not be able to return to the lifestyle they once had.

#### FACT

Living kidney donors can live a healthy, normal life with one functioning kidney. One kidney is able to function as well as two.

#### FACT

Living kidney donor does not need to be biologicially related to the recipient. Donors must have negative lymphocytotoxic crossmatch, a compatible blood type and a number of HLA antigens in common with the recipient.

#### FACT

Living kidney donor can absolutely choose the person they wish to donate their kidney to. However, there needs to a match between the donor and recipient.

#### FACT

Adults (18 or older) can be living kidney donors. The age limit at Northwell Health for a living donor is 70 years old.

#### FACT

Most donor spend 1-3 nights in the hospital and are able to return to work in 2-3 weeks. The risk of complications is very low.

#### FACT

Donating a kidney does not reduce the donor's life expectancy. Actually, people who have donated a kidney out live the average person.

#### FACT

The recipient's insurance covers the transplant and follow-up appointments. Lost wages and medical treatment post transplant is NOT covered by the recipient's insurance. There are programs that can assist in lost wages.

#### FACT

Most living donors are able to return to an independent life when they arrive home. After full recovery, a person will be able to return to their daily routine.

#### STOP BED BUGS SAFELY

#### WHAT ARE BED BUGS?

Bed bugs are small insects that feed on human blood. They are usually active at night when people are sleeping. Adult bed bugs have flat rusty-red-colored oval bodies. Adult bed bugs are about the size of an apple seed, they are big enough to be easily seen, but often hide in cracks in furniture, floors, or walls. When bed bugs feed, their bodies swell and become brighter red. They can live for several months without feeding on a host.

#### WHAT DOES A BED BUG BITE FEEL AND LOOK LIKE?

Most bed bug bites are initially painless, but later turn into large, itchy skin welts. These welts do *not* have a red spot in the center as do the bites from fleas.

#### ARE BED BUGS DANGEROUS?

Although bed bugs and their bites are a nuisance, they are not known to spread diseases.

#### HOW DOES A HOME BECOME INFESTED WITH BED BUGS?

In most cases, people carry bed bugs into their homes unknowingly, in infested luggage, furniture, bedding, or clothing. Bed bugs may also travel between apartments through small crevices and cracks in walls and floors.

#### HOW DO I KNOW IF MY HOME IS INFESTED WITH BED BUGS?

You may notice itchy skin welts. You may also see the bed bugs themselves, small bloodstains from crushed insects, or dark spots from their droppings. It is often hard to find them because they hide in or near beds, other furniture, and in cracks.

#### SHOULD I USE A PEST CONTROL COMPANY?

The Health Department recommends that homeowners hire pest control companies registered by the New York State Department of Environmental Conservation (DEC) to get rid of bed bugs. The pest control company should:

- Inspect your home to confirm the presence of bed bugs.
- Find and eliminate their hiding places.
- Treat your home with special cleaning and/or pesticides if necessary.
- Make return visits to make sure bed bugs are gone.

Be sure your pest control company hires licensed pest management professionals. Ask to see a copy of their license or check directly with DEC by calling (718) 482-4994 or visiting http://www.dec.ny.gov/permits/209.html

#### IS IT NECESSARY TO USE PESTICIDES TO GET RID OF BED BUGS?

The best way to get rid of bed bugs is to clean, disinfect and eliminate their hiding places. Since young bed bugs (nymphs) can live for several months without feeding and the adults for more than a year, the pest control company may use a pesticide. Talk with the professional about safe use of pesticides and make sure he/she:

- Uses the least toxic pesticide.
- Follows instructions and warnings on product labels.
- Advises you about staying out of treated rooms and when it is safe to reenter.

#### **HOW CAN I GET RID OF BED BUGS?**

- Find out where bed bugs are hiding in your home.
  Use a bright flashlight to look for bed bugs or
  their dark droppings in bedroom furniture. Or
  use a hot hair dryer, a thin knife, an old subway
  card or a playing card to force them out of hiding
  spaces and cracks. Check:
  - Behind your headboard.
  - In the seams and tufts of your mattress and inside the box spring.
  - Along bedroom baseboard cracks.
  - In and around nightstands,
  - Other bedroom items, including window and door casings, pictures, moldings, nearby furniture, loose wallpaper, cracks in plaster and partitions, and clutter.
- 2. Clean areas where bed bugs are likely to hide.
  - Clean bedding, linens, curtains, rugs, carpets, and clothes. To kill bed bugs, wash items in hot water and dry them on the highest dryer setting. Soak delicate clothes in warm water with lots of laundry soap for several hours before rinsing. Wool items, plush toys, shoes, and many other items can be placed into a hot dryer for 30 minutes to get rid of bed bugs.
  - Scrub mattress seams with a stiff brush to dislodge bed bugs and their eggs.
  - Vacuum mattresses, bed frames, nearby furniture, floors and carpets. Pay special attention to cracks and open spaces. Immediately after vacuuming, put the vacuum cleaner bag in a sealed plastic bag, and dispose of it in an outdoor container.
  - If you find bed bugs on a mattress, cover it with a waterproof, zippered mattress cover labeled "allergen rated," or "for dust mites." Keep the cover on for at least one year.
  - If your box spring is infested, seal it inside a vinyl box spring cover for at least one year. If no cover is available, throw the box spring away.
  - Dispose of infested items that cannot be cleaned and get rid of clutter. Seal tightly in a plastic garbage bag and discard in an outside container.
  - Repair cracks in plaster and repair or remove loose wallpaper.

- 3. Be very cautious about using pesticides yourself. Pesticides can be hazardous to people and pets. If you choose to use a pesticide, or a licensed pest control professional suggests you use one, follow these precautions:
  - Only use pesticides clearly labeled for bed bug extermination. Never use a cockroach spray, ant spray, or any other pesticide that does not list bed bugs on the label.
  - Follow label instructions exactly.
  - Never spray pesticides on top of mattresses or sofas, or in areas where children or pets are present.
  - Never purchase or use a product without a manufacturer's label and never buy pesticides from street vendors.
  - Avoid using "insecticide bombs" and "foggers" in your home. These products can spread hazardous chemicals throughout your home, and are not likely to be effective against bed bugs.

#### HOW CAN I KEEP BED BUGS OUT OF MY HOME?

- Wash clothing and inspect luggage immediately after returning from a trip.
- Inspect used furniture for bed bugs before bringing it into your home.
- Never bring discarded bed frames, mattresses, box springs, or upholstered furniture into your home.

#### HOW CAN I KEEP MY FURNITURE FROM INFESTING SOMEONE ELSE'S HOME?

- Never resell or donate infested furniture or clothing.
- If you throw infested furniture away, make it undesirable to others by cutting or poking holes in its upholstery or making it unusable. Tape a sign to it that says, "Infested with Bed Bugs."

## Give An Address

The location of the emergency is the first and most important thing operators need.
