Attendance cards MUST be punched for each session and must be kept for proof of attendance for all four courses in addition to the official grade card for each course.

In the examination, ten questions will be asked on each of the three sections: Horticulture, Flower Show Procedure and Design with the tenth question of each section taken from the required reading list.
